Quarter in Review

The 2nd quarter is April 1st – June 30th 2017. During the 2nd quarter the fund experienced an overall gain of \$2,424,145. Return on investment for the quarter was positive \$3,478,066 or 3.50% (NET).

Equity allocations led the way with a 5.00% return. This was highlighted by domestic equity DSM Large Cap Growth with a return of 9.63% and international equity WCM International Growth Fund with a return of 8.18% for the quarter.

Fiscal year to date (October 1st, 2016 – present) the fund return is 9.31% (NET) and with one quarter remaining, is well positioned to meet or exceed the assumed rate of 7.5%.



THE PENSION BOARD

Boynton Beach Fire Pension Fund is a Florida Chapter 175 Pension fund and is governed by Florida Statutes Chapter 112 & 175.

The Pension Board is comprised of five trustees. Two trustees are appointed by the City of Boynton Beach, two trustees are elected by active pension members, and one trustee is appointed by the other four. The Pension fund holds quarterly meetings, which are open to the public. Meetings are held at our offices located at Boynton Beach Fire Station 5, 2080 High Ridge Rd, Boynton Beach FL 33426.
