## INFORMAL DISABILITY HEARING CONTINUATION - MICHAEL SIDAWAY:

Mr. Levinson outlined the purpose of the meeting today, being a continuation<sup>1</sup> of an informal hearing to review the matter of the disability claim of Mr. Sidaway. Mr. Levinson recapped the status since the last meeting, advising a deposition was taken of Dr. Nocero on January 30, 2020.

At this juncture, Mr. Levinson deferred to Mr. Michael Clelland to address the Board. Mr. Clelland referred to the deposition of Dr. Nocero and his opinion that Mr. Sidaway would be on hypertension medicine for life. The type of the medicine (and the effects) would prohibit Mr. Sidaway from performing the duties of a Firefighter. Mr. Clelland also cited NFPA 1582 standards<sup>2</sup>.

During the discussion the Board also noted that the City of Boynton Beach did not have a position available for Mr. Sidaway.

Due the greater weight of the evidence presented (medical records and live testimony of Mr. Sidaway), Mr. Taylor made a motion to grant the service disability effective immediately. Mr. Sidaway is unable to perform the duties of a Firefighter, his condition (related to the Heart Bill) is total and permanent. As the city does not have a position for Mr. Sidaway, he is unable to provide useful and efficient service. The motion was seconded by Mr. Raybuck. The Motion passed 5-0.
