Quarter in Review

The 2nd quarter is April 1st – June 30th 2018. During the 2nd quarter the fund experienced an overall gain of \$1,378,918. Return on investment for the quarter was positive at \$1,780,081 or 1.53% (NET).

Domestic Equity allocation led the way with a 3.34% return. This was highlighted by DSM Large Cap Growth with a return of 4.72% and Vanguard 500 Index Admiral with a return of 3.42% for the quarter.

In addition, the Real Estate allocation, Intercontinental, experienced a strong quarter with a return of 2.89%.



THE PENSION BOARD

Boynton Beach Fire Pension Fund is a Florida Chapter 175 Pension fund and is governed by Florida Statutes Chapter 112 & 175.

The Pension Board is comprised of five trustees. Two trustees are appointed by the City of Boynton Beach, two trustees are elected by active pension members, and one trustee is appointed by the other four. Trustee's terms are for a four year period. For more information on Chapter 175 pension fund board of trustees, please reference the Florida Statute 175.061

The Pension fund holds quarterly meetings, which are open to the public. Quarterly meetings are held at Boynton Beach Fire Station 5, 2080 High Ridge Rd, Boynton Beach FL 33426.

The Pension Board is assisted by an administrator, consultant, actuary, attorney, and custodian in order to properly and efficiently manage the fund.

The Pension Board is a member of the Florida Public Pension Trustee Association, FPPTA, and the National Conference on Public Employee Retirement Systems, NCPERS.
